OPEN 7 DAYS A WEEK, BARCS PROVIDES CARE AND REHABILITATION TO ABUSED AND ABANDONED ANIMALS IN NEED, PROVIDES LOW COST SPAY/NEUTER SERVICES TO LOW INCOME FAMILIES AND FREE SPAY/NEUTER SERVICES FOR OUTDOOR CATS, ASSISTS IN RETURNING LOST ANIMALS TO THEIR OWNERS AND FINDS SUITABLE HOMES FOR ANIMALS WITHOUT OWNERS, AND PROVIDES RESOURCES TO THE COMMUNITY TO HELP PETS STAY IN THEIR HOMES. PRIOR TO BARCS INCEPTION IN 2005, THE EUTHANASIA RATE WAS 98%. DUE TO BARCS LIFESAVING EFFORTS, THE EUTHANASIA RATE HAD DECREASED TO 10% WHICH INCLUDES ANIMALS THAT ARE AGGRESSIVE, HAVE MEDICAL INJURIES BEYOND REPAIR, OR WHO ARE TRULY AT THE END OF THEIR LIFE.
